Subject: Urgent Appeal for Investigation into Crimes Committed Against Tigrayan Civilians

Dear Prosecutor Karim A. A. Khan KC,

I am writing to urgently appeal to the Office of the Prosecutor at the International Criminal Court (ICC) to investigate and prosecute those responsible for the atrocities committed against Tigrayan civilians between 2020 and 2022. During this period, an estimated 600,000 Tigrayan civilians lost their lives due to targeted violence, starvation, and other crimes against humanity.

Despite the overwhelming evidence documented by international organizations, no arrest warrants have been issued for the perpetrators of these crimes. This lack of action stands in sharp contrast to the swift issuance of warrants for other crises, such as the case against President Vladimir Putin for the abduction of 20,000 Ukrainian children. The principle of

impartiality demands that all human lives be valued equally, regardless of their geographic location or political context.

The scale and gravity of the crimes against Tigrayans—systematic ethnic cleansing, sexual violence, and deliberate humanitarian blockades—meet the threshold of crimes within the ICC’s jurisdiction. Survivors and affected families deserve justice, and further delay only deepens the suffering and erodes public confidence in international law.

I respectfully urge your office to:

1. Initiate an independent investigation into the crimes committed against Tigrayan civilians during the 2020-2022 conflict.
2. Prioritize the issuance of arrest warrants for those found responsible for orchestrating and carrying out these atrocities.
3. Publicly address the delay in action and affirm the ICC's commitment to upholding justice without bias.

Justice delayed is justice denied. The world is watching, and the people of Tigray cannot afford further silence. I trust in your mandate to ensure that no perpetrator is beyond the reach of the law, and I urge you to act now.

Thank you for your attention to this urgent matter. I look forward to your office's decisive action to deliver justice for the victims and their families.
